Easily create, approve, and monitor time-bound, role-based privileged sessions. Enable just-in-time (JIT) access that provides users with elevated access to resources and monitor privileged activity as it occurs, or access the session recording later. Once any session is terminated, so is any future access unless a new session is spun up.

REDUCE RISK WITH ADVANCED ANALYTICS

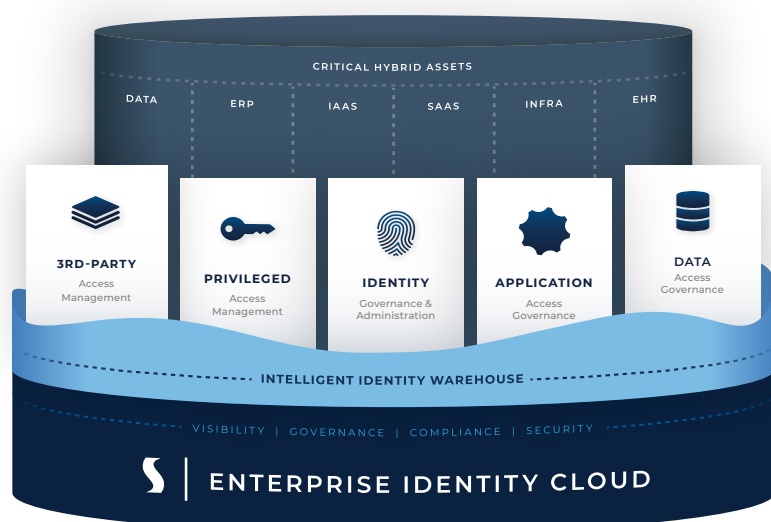
